Statement of Lien Claimant's Demand: \$1,409,575.36 through September, 1996 with costs and expenses continuing to accrue.

Comments: Written demand was made upon Donald and Evelyn Rider on October 29, 1996 for reimbursement of Department of Environmental Quality (DEQ) remedial action costs and expenses resulting from investigation and cleanup activities on Klamath County Tax Lot 3809-32AB-4800, a parcel of land described as follows:

Beginning at the most Southerly corner of Lot 2, Block 38 of Original Town of Linkville now City of Klamath Falls, Oregon; thence, Northwesterly at right angles to Klamath Avenue 115 feet; thence Northeasterly and parallel with Klamath Avenue 20.5 feet; thence Southeasterly at right angles to Klamath Avenue 115 feet to the Northwesterly line of Klamath Avenue; thence Southwesterly along the Northwesterly line of Klamath Avenue 20.5 feet to the place of beginning.

Statement of the failure of the person to conduct removal or remedial action and pay penalties and damages as required: Donald and Evelyn Rider have failed to conduct remedial action or pay DEQ remedial action costs, penalties, or damages.

This Statutory Lien exists and continues until the liability for such costs, penalties, or damages is satisfied.
