 - (iii) at an acquisition cost v/hich is greater than 90 percent of the average area purchase price (greater than 110 percent for targeted area residences), all as provided in Section 143(a) and (I)(2) of the Internal Revenue Code; or
 - (iv) who has a gross family income in excess of the applicable percentage of applicable median family income as provided in Section 143(f) and (I)(2) of the Internal Rayenue Code; or
