RESOLUTION # 97-033

WHEREAS, on the 10th day of September, 1996, Washburn Airport Partners, a partnership consisting of Donald Ekstrom, Stephen Tofft, David Gray, Ronald Sumner and Ben DeGroot, Grantor, conveyed to Klamath County, Oregon certain property for County Road purposes, described as follows:

A parcel of land lying in NE1/4 NE1/4 of Section 21, Township 39 South, Range 9 East, W.M., Klamath County, Oregon and being a portion of that property described in that deed to Washburn Airport Partners, recorded June 23, 1987 in Volume M87, Page 10800 of Klamath County Record of Deeds; the said parcel being that portion of said property included in a strip of land variable in width, lying on the Westerly side of the centerline of relocated Washburn Way, which centerline is described as follows:

Beginning at Engineer's centerline Station 'WW' 77+06.59, said station being 242.00 feet North and 26.77 feet East of the Northeast corner of Section 21, Township 39 South, Range 9 East, W.M.; then South 2°21'38" West 578.99 feet; thence on a 7,639.44 foot radius curve left (the long chord of which bears South 1°17'57" West 283.06 feet) 283.07 feet; thence South 0°14'15" West 717.31 feet to Engineer's centerline Station 'WW' 92+85.96.

The width in feet of said strip of land is as follows:

This parcel of land contains 17,493 square feet, more or less.




