

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on November 8, 1996, KLAMATH COUNTY, A Public Corporation of the State of Oregon, as vendor and Gerald D. Orndoff & Elizabeth A. In Witness Whereof the said vendor has executed this memorandum December 4, 1996.

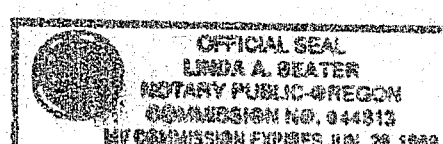
