

MEMORANDUM OF LAND SALE AGREEMENT

In Witness Whereof the said vendor has executed this memorandum December 4, 1996.

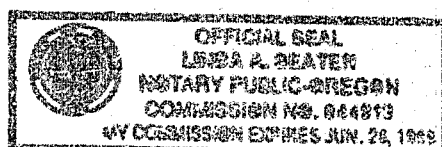
