

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated April 16, 1991, executed and delivered by Mark R. Wendt & Karen A. 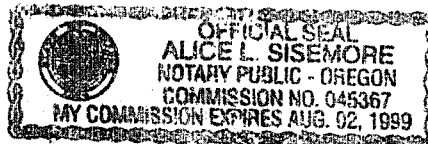
