MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on July 15, 1996, KLAMATH COUNTY, A Public Corporation of the State of Oregon, as vendor and Edward Louis Oueilhe & Deborah L. Oueilhe, Trustees of the Oueilhe Family Trust Dated March 25, 1995, as vendee(s) made and entered into a certain Land Sale Agreement wherein said vendor agreed to sell to said vendee(s) and the latter agreed to purchase from said vendor the fee simple title in and to the following described real property in Klamath County, State of Oregon, to-wit:

Lots 1 & 2, Block 1, First Addition To Chiloquin, Oregon situated in Section 34, Township 34 South, Range 07 East of the Willamette Meridian, Klamath County, Oregon. EXCEPT the Southwesterly 20 feet of Lot 2, Block 1, First Addition To Chiloquin, Oregon.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$1,265.65, all deferred payments bear interest at the rate of 9% per annum from the date of said Land Sale Agreement until paid.

In Witness Whereof the said vendor has executed this memorandum December 10, 1996.

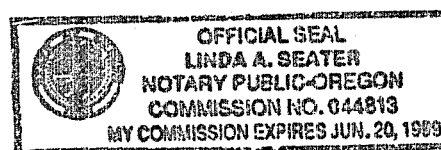
