THIS DEED made this 12th day of June

19 96, between REGINALD B. MADSEN, United States Marshal for the District of Oregon, herein ifter called "Marshal," and GEORGE SIMEONOV, hereinafter called "Grantee:"

WITNESSETH:

WHEREAS, in a suit in the United States District Court for the District of Oregon, between the UNITED STATES OF AMERICA, Plaintiff, and GLEN E. DERRA, et ux, et al., Defendants, Civil No. 95-138-AS, a judgment and decree was entered on September 28, 1995, for the foreclosure of a mortgage on real property described below; and
