- All wells shall be maintained in a condition where they are not a threat to public health or safety, a source of contamination, 2
- All wells shall be securely covered to prevent any foreign substance from entering the well. 3.
- All wells shall be equipped with an access port or airline so that static water level information can be determined at any time. 4
- Well casing must be protected from damage and meet minimum extension requirements. 5.

Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment must be carried out in accordance with state rules.
