3. Representations of Grantor Grantor represents that:

4. Sale Or Transfer Of Property If the Property or any interest the ein is sold or otherwise transferred by Grantor without Grantor first repaying in full the Debt and all other sums secured hereby, or if Grantor agrees to sell or transfer the property or any interest therein without first repaying in full the Debt and all other sums secured hereby, the entire Debt shall become immediately due and payable without notice from Beneficiary and bear interest at the Default Rate less that term is defined belowl from the date of the sale or transfer until paid in full. 5. Promises of Grantor Grantor promises:

(a) To keep the Property in good repair; and not to move, a ten or demolish any of the improvements on the Property without Beneficiary's prior written consent;

(b) To allow representatives of Beneficiary to inspect the Property at any reasonable hour, and to comply with all laws, ordinances, regulations, coverants, conditions and restrictions effect ing the Property;

(c) To pay on time all lawful taxes and exsessments on the Property;

(d) To perform on time all terms, coverants and conditions of any prior mortgage or dead of trust covering the Property or any part of it and pay all amounts due and owing therounder in a timply manner;

(e) To keep the Property and the improvements thereon insured by a company satisfactory to Beneficiary against fire and extended coverage perils, and against such other risks as Benoficiary require, in an amount equal to the full insurable value of the improvements, and to deliver evidence of such insurance coverage to 3 nefficiary. Beneficiary shall be named as the loss payed on all such policies pursuant to a standard lender's less payable clause; and

(f) To see to it that this Deed of Trust remains: a valid lien on the Property superior to all liens except those described in Section 3, and to keep the Property free of all encumbrances which may impair Beneficiary's security. It is agreed that it anyone asserts the priority of any encumbrance (other than those described in Section 3) over this Deed of Trust in any pleading filed in any ection, the assertion alone shall impair the lien of this Deed of Trust for purposes of this Section 5(f).

6. Curing of Defaults If Grantor fails to comply with any of the covenants in Section 5, including compliance with all the terms of any prior mortgage or deed of trust. Beneficiary may take any action required to comply with any such covenants without waiving any other right or remedy it may have for Grantor's failure to comply.
