

EXHIBIT "A"

the following described real property located in Klamath County, Oregon, to-wit:

PARCEL 1:

Commencing at the Southwest corner of Section 31, Township 40 South, Range 11 East of the Willamette Meridian, and extending thence North along the West Section line of said Section 31 to the East-West center line of said Section 31; thence East along said center line to the Southeast corner of the $W\frac{1}{2}SW\frac{1}{4}NW\frac{1}{4}$ of said Section 31; thence North along the East line of said $W\frac{1}{2}SW\frac{1}{4}NW\frac{1}{4}$ to the center line of the U. S. Bureau of Reclamation "D" Canal, formerly the "Adams" Canal; thence Southeasterly along the center line of said "D" Canal to the center line of a certain private drain ditch located 1320 feet, more or less, East of the West line of said Section 31; thence South along the center line of said drain ditch to the South Section line of said Section 31; thence West along said South Section line 1320 feet, more or less, to the point of beginning, and containing 85 acres, more or less.

PARCEL 2:

The Northwest quarter of Section 36, Township 40 South, Range 10 East of the Willamette Meridian, except the following:

a. That portion of the South one-half of said Northwest quarter of Section 36 lying and being southerly and westerly of the Klamath Irrigation District Drain Right of Way which crosses said $S\frac{1}{2}NW\frac{1}{4}$;

b. That portion of the Northwest quarter of said Northwest quarter lying and being north of the United States G Canal right of way;

c. That portion of the Northwest quarter of said Northwest quarter described as follows:

Beginning at the intersection of the Section line between Sections 35 and 36 in said Township and Range and the right of way line of the South side of said canal; thence South along said Section line 305.5 feet; thence East 714 feet; thence North parallel to said section line to the said South right of way line of said canal; and thence Westerly along said right of way line of said canal to the point of beginning, containing approximately 7.032 acres of land;

d. That portion of the above described land included in the rights of way for irrigation ditches and drains heretofore granted and reserved unto the United States.
