feminine and the neuter and the singular number includes the plural.

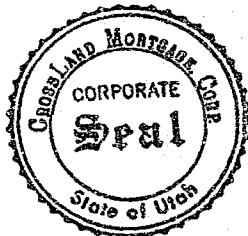

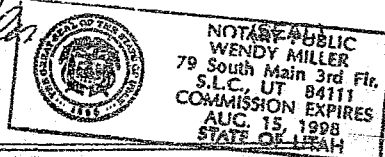
