KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 28, 19 78, executed and delivered by Mark J. Sites & Pamela D. 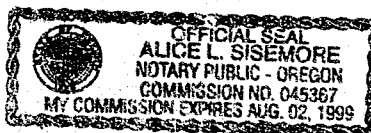
