DEED OF TRUST

THIS DEED OF TRUST is made this December 11, 1996, among the Grantor, Charles J. Radford and Melinda L. Radford (herein "Borrower"), Norwest Bank Colorado, National Association (herein "Trustee"), and the Beneficiary, NORWEST BANK COLORADO, NATIONAL ASSOCIATION, a corporation organized and existing under the laws of the United States of America, whose address is P. 19. Assignment of Rents; Appointment of Receiver; Lender in Possession.
