CERTIFICATION OF TRUST

10. No Change In Trust. The trust has not been revoked, modified or amended in any manner that would cause the representations contained in this certification to be incorrect.

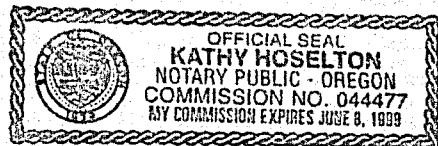
