DEED OF RECONVEYANCE

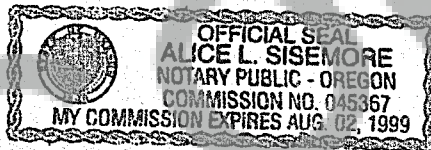
