Parcel 2:

A Parcel of land situated in the E'/2 of Section 13, Township 39 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, and being more particularly described as follows:

Beginning at the ½ corner common to Sections 13 and 24, Township 39 South, Range 9 East of the Willamette Meridian, thence North along the North South center section line 30.00 feet to the true point of beginning, thence continuing North along the North South center section line 4190.0 feet to the intersection with the Southerly right of way line of the U.S.B.R. A-Canal, thence Southeasterly along the Southerly right of way line of said canal to its intersection with the centerline of a drain ditch, some 620 feet East of the West line of the E½ of said Section 13; thence in a generally Southerly direction along said canal centerline to its intersection with the centerline of a second drain ditch; thence in a generally Southeasterly direction along the centerline of the second drain ditch, to a point that is some 565 feet East of the West line of the E½ of said Section 13; thence due South to a point 30 feet North of the South line of said Section 13; thence West 503 feet, more or less; to the point of beginning.
