NOW KNOW YE, that there is, therefore, granted by the UNITED STATES unto GENESIS PROPERTIES, the land above described; TO HAVE AND TO HOLD the said land with all the rights, privileges, immunities, and appurtenances, of whatsoever nature thereunto belonging, unto GENESIS PROPERTIES, its successors and assigns, forever; and

EXCEPTING AND RESERVING TO THE UNITED STATES from the land so granted, a right-of-way thereon for ditches or canals constructed by the authority of the United States (Act of August 30, 1890, 43 U.S.C. 945).
