UNIFORM STATUTORY DURABLE POWER OF ATTORNEY (California Probate Code Section 4401)

1. DESIGNATION OF AGENT.

I, JAMES R. DeBAUN, of Los Angeles, California, do hereby appoint my wife, JAYNE S. DeBAUN, as my attorney-in-fact to act for me in any lawful way with respect to all of the following subjects. In the event she is unable or unwilling for any reason whatsoever, I then appoint my son, RUSSELL LOUIS DeBAUN, to so act:

- (1) Real property transactions;
- (2) Tangible personal property transactions;
- (3) Stock and bond transactions;
- (4) Commodity and option transactions;
- (5) Banking and other financial institution transactions:
- (6) Business operating transactions;
- (7) Insurance and annuity transactions;
- (8) Estate, trust and other beneficiary transactions;
- (9) Claims and litigation;
- (10) | Personal and family maintenance;
- (11) Benefits from social security, medicare, medicaid, or other governmental programs, or civil or military service;
- (12) Retirement plan transactions;
- (13) Tax matters;
- (14) ALL OF THE POWERS LISTED ABOVE.

2. CREATION OF DURABLE POWER OF ATTORNEY.

By this document I intend to create a general power of attorney under the Uniform Statutory Form Power of Attorney Act of the California Civil Code. This power of attorney is effective immediately, and will continue until it is revoked. Subject to any

limitations in this document, this power of attorney is a durable power of attorney and will continue to be effective even though I may become incapacitated.

3. RELIANCE BY THIRD PARTIES.

I agree that any third party who receives a copy of this clocument may act under it. Revocation of this power of attorney is not effective as to a third party until the third party has actual knowledge of the revocation. I agree to indemnify the third party for any claims that arise against the third party because of reliance upon this power of attorney.
