A. ADDITIONAL PROPERTY SUBJECT TO THE SECURITY INSTRUMENT. - C. ASSIGNMENT OF LEASES. Upon Lender's request, Borrower shall assign to Lender all leases of the Property and all security deposits made in connection with leases of the Property. Upon the assignment, Lender shall have the right to modify, extend or terminate the existing leases and to execute new leases, in Lender's sole discretion. As used in this paragraph G, the word "lease" shall mean "sublease" if the Security Instrument is on a leasehold.

This assignment of Rents constitutes an absolute assignment and not an assignment for additional security only.
