## PRENUPTIAL AGREEMENT

CHRISTINE and GARY GRAHAM enter into this agreement which is a prenuptial agreement.

Christine Graham owns:

- (1) 1995 Dodge pickup
- (2) 1992 Dodge pickup

In this agreement no money is exchanged by either party. The purpose of this agreement is a way to combine all property, because of a marriage. If either party wishes to separate and divorce before three (3) years at the marriage, then everything in this agreement will return to each party as owned prior to this agreement. After three years, all property will be as a married couple.

Each party has a right of survivorship in the evert of an untimely death.

Christine will maintain \$100,000 term life with Gary as the beneficiary.

Gary will maintain \$100,000 term life with Christine as the beneficiary.

All moneys that come into this relationship will be placed in a joint checking account requiring dual signatures in the sole responsibility of that party.
