DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated August 2, 1993, executed and delivered by Charles T. Whitlatch and Pamela S. 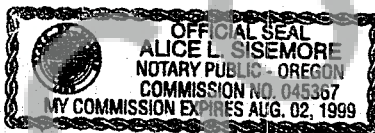
