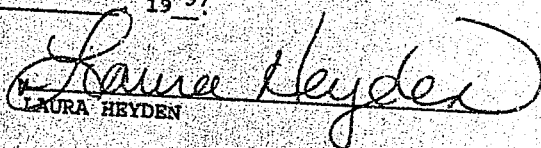

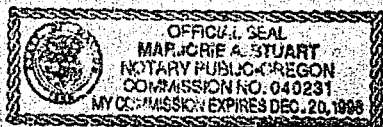

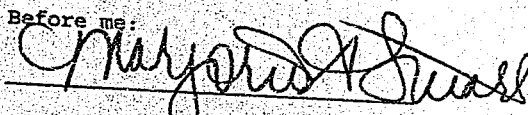

LEGAL DESCRIPTION
