DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated January 12, 1995, executed and delivered by James M. Nowaski and Tami L. 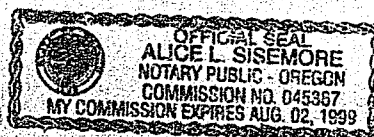
