KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 14, 1988, executed and delivered by Joe L. Keller and Rosie A. Keller, husband and wife and Walter Marius Petersen and Jean Y. 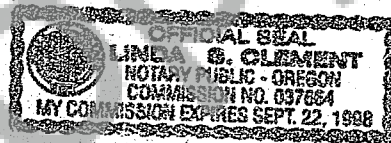
