## 4. ADJUSTABLE INTEREST RATE AND MONTHLY PAYMENT CHANGES

## (A) Change Dates

The initial fixed interest rate I will pay will change to an adjustable interest rate on the first day of MAY , 2004, and the adjustable interest rate I will pay may change on that day every 12th month thereafter.
