1. NATURE OF THE ASSERTED VIOLATION:

Respondent is alleged to have stored an excessive number of wrecked/inoperable/unlicensed vehicles at a residential real property civilly described as 3529 Crest Street, Klamath Falls, Oregon. From the record, it appears that the Respondent was afforded until March 21, 1997 to show to the Hearings Officer satisfactory progress toward bringing the residential real property (particulary the number of wrecked/inoperabale/unlicensed vehicles) into compliance with the code.
