DEED OF RECONVEYANCE

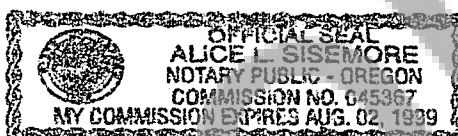
