DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, BARBARA KAY SHAW, who was formerly known as Barbara Kay Lindsay, have made, constituted and appointed, and by these presents do hereby make, constitute and appoint THOMAS J. SHAW as my true and lawful attorney for me and in my name, place and stead, and for my use and benefit to undertake the following acts:

- a. Demand, sue for, recover, collect and receive all such sums of money, debts, rents, dues, accounts, devises and legacies, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to me, to have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, and to compromise, settle and adjust and to execute and deliver releases or other sufficient discharges for any of the same;
- b. To bargain, contract for, purchase, receive and take lands, tenements, hereditament, and accept the title and possession thereof and all deeds and other assurances in the law therefor and to lease, rent, bargain, sell, release, convey, mortgage and hypothecate lands and tenements, including my right of homestead in any of the same for such price, upon such terms and conditions and with such covenants as my said attorney shall think fit;
- c. To sell, transfer and deliver all or any shares of stock owned by me in any corporation for any price and receive payment therefor and to vote any such stock as my proxy;
- d. To bargain for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares and merchandise, choses in action, and other property in possession or in action, and to make, do and transact all and every kind of business of whatsoever nature or kind;
- e. For me and in my name and as my act and deed, to sign, seal, execute, acknowledge and deliver all deeds, covenants, indentures, agreements, trust agreements, mortgages, pledges, hypothecations, bills of lading, bills, bonds, notes, evidences of debt, receipts, releases and satisfactions of mortgages, judgments and other debts payable to me and other instruments in writing of whatever kind and nature which my said attorney in her absolute discretion shall deem to be for my best interests;
- f. To have access to any safety deposit box which has been rented in my name, or in the name of myself and any other person or persons;
- g. To sell, discount, endorse, deliver and/or deposit all checks, drafts, notes, and negotiable instruments payable to my order, to withdraw any moneys deposited in my name with

any bank, by check or otherwise, and generally to do any business with any bank or banker on my behalf,

h. To complete, sign, and deliver any tax return or form and pay taxes thereon or collect refunds therefrom.

I GIVE AND GRANT unto each of my said attorneys full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney or my said attorney's substitute or substitutes shall lawfully do or cause to be done by virtue of these presents. Each of my attorneys in fact is specifically authorized to undertake and execute each such act individually and without the knowledge, participation, approval or concurrence of the other named attorney in fact.

This power shall take effect on the date next written below.

My said attorney and all persons unto whom these presents shall come may assume that this power of attorney has not been revoked until given actual notice either of such revocation or of my death.

In construing this instrument and where the context so requires, the singular includes the plural.

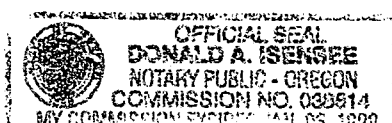
