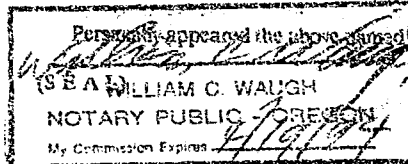
The true and actual consideration paid for this transfer, stated in terms of dollars is One Thousand Dollars (\$1,000).
