Undivided 1/6th interest in the Estate of Loia Stone as relates to the following described real property:

West half of Lot 674 in Block 107 of Mills Addition to the City of Klomath Falls

This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations.
