12 114.515.


13 (1) I represent that my brother, MICHAEL J. TODD, and I are the sole heirs and

EXHIBIT "A"
LEGAL DESCRIPTION

A piece or parcel of land situated in the SE1/4 SW1/4 of Section 30, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows: Beginning at the point of intersection of the Southerly boundary of Section 30, Township 39 South, Range 9 East of the Willamette Meridian, and a line parallel with and fifty (50.00) feet distant at right angles Southeasterly from the center-line of the Klamath Falls-Nidland section of the Oregon State Highway, as the same is presently located and constructed and from which point of intersection 30° West, 927.1 feet distant; thence North 36° degrees 49' 30" East, parallel to the center-line of said highway 1475.6 feet to a 3/4" iron pin and the true point of beginning of this description; thence North 89° degrees 41' 10" East; thence 711.8 feet to a 5/8" aluminum capped iron pin; thence North 1 degree 54' 40" East 165.5 feet to a 3/4" iron pipe in the existing East-West fence which is generally accepted as the North boundary of the SE1/4 SW1/4 of said Section 30; thence South 89° degrees 59' 10" West along said existing fence 607.0 feet to a 3/4" iron pipe at the intersection with the Southeasterly Highway right-of-way fence; thence South 36° degrees 50' West along said existing right-of-way fence 183.6 feet, more or less, to the true point of beginning.
