DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 10, 1993; August 26, 1994, executed and delivered by Raymond E. 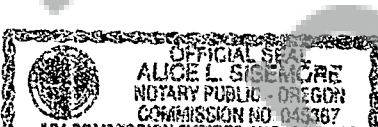
