- 1. The assessment roll and the tax roll disclose that the within described premises were specifially assessed as farm land. - 2. Reservations and restrictions, including the terms and provisions thereof, as contained in deed executed by the United States of America to Charles Nash, dated Decmeber 18, 1939, recorded January 11, 1940, in Volume 126 page 360, Deed records of Klamath County, Oregon, as follows: "...subject to any vested and accrued water rights or ditches and reservoirs used in connection with such water rights as may be recognized and acknowledge by the local customs, laws and decisions of courts; and there is reserved from the lands hereby granted, a right of way thereon for ditches or canals constructed by the authority of the United States. Subject to such rights for telephone line purposes as the Pacific Telephone and Telegraph Company may have under the Act of March 4, 1911."
- 3. Right of Way, including the terms and provisions thereof, given by George F. Sly (also known as George T. Sly), a single man, to Pacific Gas Transmission Company, a California corporation, dated January 4, 1960, recorded March 21, 1960, in Volume 319 page 541, as modified by Notice of Location, dated September 25, 1961, recorded September 25, 1961, in Volume 332 page 574, as amended by Notice of Location, dated November 30, 1978, recorded January 17, 1979, in Volume M79 page 1272, Deed records of Klamath County, Oregon.

Memorandum of Contract for Line Extension, including the terms and provisions thereof, by and between Midstate Electric Cooperative, Inc., and Stan Russell and Don Yow, DBA LaPine Sand & Gravel, dated September 8, 1995, recorded October 26, 1995, in Volume M95 page 29265, Deed records of Klamath County, Oregon.
