MODIFICATION OF DEED OF TRUST

DEED OF TRUST. Grantor and Lender have entered into a Deed of Trust dated April 15, 1992 (the "Deed of Trust") recorded in Klamath County. Slate

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property (the "Real Property") recorded in Klamath County. State of Oregon:

Lots 1, 2 and 3, and the Easterly 58.5 feet of Lot 4, Block 21, original Town of LINKVILLE, now the City of Klamath Falls, Oregon, in the County of Klamath, State of Oregon.

Also Lot 1 and the Easterty 24 feet of Lot 2, Block 22; also that part of closed Center Street lying between Lot 1 of Block 22 and Lot 4 of Block 21, Being the Southerly one-half of closed Center Street; also the Westerly 8 Feet of lot 4, Block 21; all being part of the Original Town of LINKVILLE, now the City of Klamath Falls, Oregon, in the County of Klamath, State of Oregon.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Dead of Trust (the "Note"). It is the intention of Lender to relain as liable all parties to the Deed of Trust and all parties, agreement secured by the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, makers and endorsers to the Note, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification but also to all such subsequent actions.
