WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That DENNIS A. KALINA, SHERMAN O. KALINA, and JERRY L. KALINA, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by DENNIS A. KALINA and SHERMAN O. KALINA, SUCCESSOR TRUSTEES OF THE KALINA FAMILY TRUST, U.A.D. APRIL 18, 1989, hereinafter called the grantee, do hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lots 15, KALINA ADDITION TO MALIN, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO: Reservations, restrictions, easements and rights-of-way of record and those apparent on the ground, including, but not limited to, reservations contained in the plat dedication; the statutory powers, including the power of assessment, of the Malin Irrigation District; a 20' building set back as shown on the dedicated plat.

FURTHER SUBJECT TO: A 10' easement for irrigation purposes along the southerly boundary of said lot.

NO DWELLING OTHER THAN A SINGLE FAMILY UNIT SHALL BE ERECTED ON THIS PROPERTY AND THE RESIDENCE MUST BE A MINIMUM FLOOR AREA OF 1200 SQUARE FEET. THIS COVENANT SHALL RUN WITH THE LAND.

TO HAVE AND TO HOLD the same unto the said grantee and grantee's heirs, successors and assigns forever.

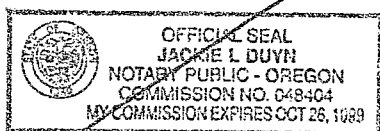
