This matter came before Michael L. Brant, Hearings Officer for Klamath County, Oregon, on June 6, 1997, in the Klamath County Museum Meeting Room in Klamath Falls, Oregon. The hearing was held pursuant to notice given in conformity with the Klamath County Land Development Code and related statutes and The Klamath County Planning Department was ordinances. represented by Mr. Kim Lundahl and the recording secretary was Assistant Planner Karen Burg. The Klamath County Planning Department file and all the exhibits and other contents therein is incorporated by this reference into this matter. The Klamath County Planning Department staff report was received. The Applicants appeared. Based upon the evaluation of the Staff Report and consideration of the other evidence received, the Hearings Officer makes the following findings of fact and conclusions and makes the following decision.

FINDINGS OF FACT

The Applicants want to partition an approximate 2.4 acre parcel into two 1.2 acre parcels which would each accommodate a single family non-farm residence. The subject property is located within

an EFU Zone and the subject parcel was created for non-farm use by a Land Partition prior to January 1, 1993.

DLCD called our attention to LUBA decision, Robert Harrell, Jr. and Harrell Land and Livestock, LTD. v. Baker County (28 OR LUBA 260 which held that ORS 215.263 (7) and ORS 215.284 (2) (c) prohibit further division of an EFU zoned parcel created prior to January 1, 1993.

CONCLUSION

Klamath County is prohibited by State Law from granting the Land Partition requested.

The 2.4 acre parcel has been previously approved for a non-farm use dwelling.

ORDER

The requested Land Partition is denied.
