

SPECIAL LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, Connie Strine, Securities Transaction Technician of the Federal Deposit Insurance Corporation ("FDIC"), pursuant to applicable resolutions of the Board of Directors of the FDIC, hereby appoint, authorize and empower each of the following persons listed on Exhibit A, attached hereto and made a part hereof, as attorney(s)-in-fact, to act on behalf of the FDIC in either its corporate capacity or in its capacity as conservator or receiver for the institutions listed in Exhibit B, attached hereto and made a part hereof, (FDIC being (i) successor to Resolution Trust Corporation ("RTC") in its capacity as conservator or receiver for such institutions pursuant to 12 U.S.C. §1441a(m)(1), and (ii) manager of the fund that is the transferee of all assets and liabilities of the RTC in its corporate capacity pursuant to 12 U.S.C. §1441a(m)(2)), according to the following powers and terms:

To execute, individually and not jointly any and all: (i) satisfactions of mortgages or lien transfers and reconveyances of deeds of trust for the purpose of completing satisfactions due to payoffs; (ii) lost note affidavits; mortgage note endorsements; allonges; assignments of mortgage, deeds of trust or related documents; (iii) assignments, terminations, renewals or continuations of U.C.C. Financing Statements; (iv) assignments, satisfactions or reassignments of assignments of rents, leases and profits; (v) affidavits of recordation in error; and (vi) special warranty deeds, and such other documents and instruments as may be necessary or convenient to effectuate the disposition and transfer of assets ("Assets") in accordance with the provisions of certain Pooling and Servicing Agreements referenced in Exhibit C, attached hereto and made a part hereof (the "Agreements"), provided however, those individuals listed in Exhibit A who are not FDIC employees are only authorized to execute such documents and instruments necessary or convenient to effectuate the disposition and transfer of assets to certain Trustees acting as trustees under the Agreements referenced in Exhibit C. All documents referenced herein shall be executed pursuant to the authority and procedures detailed in the Agreements.

This Special Limited Power of Attorney shall be effective as of January 1, 1996 and shall continue through the earlier of (1) with respect to any individual listed on Exhibit A, the termination of their service in the described capacity or (2) December 31, 1997.

IN WITNESS WHEREOF, the FDIC by its duly authorized officers empowered in that behalf by appropriate Resolution of its Board of Directors, has caused these presents to be subscribed in its name and its corporate seal to be thereunto affixed this 4th day of December, 1996.
