In addition to the above, owners of properties on which a well is located are responsible for maintaining that well in a proper manner. Some basic requirements are listed below:

- All wells shall be maintained in a condition where they are not a threat to public health or safety, a source of contamination, 1. or a waste of the groundwater resource.
- 2. All wells shall be securely covered to prevent any foreign substance from entering the well.
- 3. All wells shall be equipped with an access port or airline so that static water level information can be determined at any time. 4.
- Well casing must be protected from damage and meet minimum extension requirements.
- 5. Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment must be carried out in accordince with state rules.
