KNOW ALL MEN BY THESE PRESENTS, that I, as Principal, do hereby nominate, constitute and appoint Appointee as my true and lawful attorney in fact to execute and perform the following stated powers:

1. I, Principal, do hereby give and grant unto my said attorney in fact full power and authority to do and perform every act necessary, requisite or proper to be done in and about the premises as fully as I might or could do were I personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney shall lawfully do or cause to be done by virtue hereof.

This power of attorney is granted for a period of 1 Year and shall become effective on May 22, 1997 and shall terminate on May 22, 1998.


