CONFORMANCE WITH RELEVANT KLAMATH COUNTY POLICIES:

Notice was sent out to 7 surrounding property owners as well as to 4 agencies of concern. No negative response was received from any of the notified parties. KCFD No. 1 responded indicating they have no concerns with the proposal.

A Variance thall be granted only upon finding by the review authority that it satisfies the following criteria:

- A. That the literal enforcement of this Code would result in practical difficulty or unnecessary hardship.
- B. That the condition causing the difficulty was not created by the applicant.
- C. That the granting of the Variance will not be detrimental to the public health, safety and welfare or to the use and enjoyment of adjacent properties and will not be contrary to the intent of this code.

Literal enforcement of the Code would cause unnecessary hardship because of the lot size and iccation of the existing home. Applicant wishes to establish an accessory building (garage) and to maintain the six foot distance requirement between structures, it needs to encroach into the side setback.

The condition causing the difficulty was not created by the applicant. The lot size and shape create the difficulty.

In review of this application, it would appear not to be detrimental to the adjacent properties or to the public. Seven surrounding property owners were notified of this request. No negative response was received from any of the notified parties.
