Said facilities to be placed along and adjacent to Easterly-Westerly roadways, as they exist, located along and adjacent to the Northerly and Southerly boundaries of said described property, and also along and adjacent to a Northerly-Southerly power utility pole line, as it exists, located in the Easterly portion of said described property.

Situated in the County of Klamath, State of Oregon. It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction, provided, however, that the Company shall have the right to clear and keep cleared trees or other obstructions which may interfere or threaten to interfere with the exercise of the Company's rights granted hereunder.
