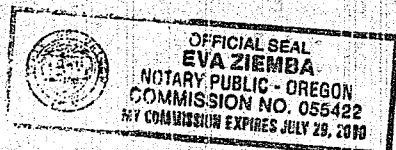
BARGAIN AND SALE DEED
