## QUITCLAIM DEED

STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Grantor, for no monetary consideration does relinquish and forever quitclaim unto the STATE OF OREGON, by and through its PARKS AND RECREATION DEPARTMENT, Grantee, all of Grantor's right, title, and interest in and to the following described property:

A parcel of land lying in Sections 4, 9, 10 and 11, Township 34 South, Range 7 East, W.M., Klamath County, Oregon and being that property described in those deeds to the State of Oregon, by and through its State Highway Commission, recorded January 3, 1946 in Book 183, Page 475, recorded October 1, 1958 in Book 304, Page 221, recorded November 28, 1958 in Book 307, Page 30, recorded September 13, 1960 in Book 324, Page 97, recorded March 26, 1962 in Book 336, Page 280 and being that property described in that deed to the State of Oregon, by and through its Department of Transportation, Parks and Recreation Division, recorded in Book M-81, Page 17803, all of Klamath County Record of Deeds.

EXCEPT therefrom that portion of said property recorded in Book M-81, Page 17803 lying within the W $\frac{1}{4}$ NW $\frac{1}{4}$  and the NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 11, Township 34 South, Range 7 East, W.M., Klamath County, Oregon.

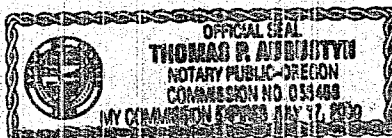
