KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 15, 1991, executed and delivered by Jack L. Stewart & Joni M. 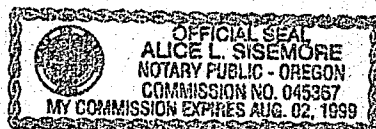
