## MTC 41457-KR AGREEMENT

THIS AGREEMENT entered into this \_\_\_\_\_\_\_ day of July, 1997, by between AAA DISCOUNT STORAGE, LLC, through L. A. Swetland, its president (hereinafter referred to as "First Party"), and ENTERPRISE IRRIGATION DISTRICT, through Donald D. Russell, its manager (hereinafter referred to as "Second Party").

## RECITAL

WHEREAS, First Party is the owner of a real property described as Parcel 2 of Land Partition 11-95, which partition was approved in Klamath County, Oregon; and WHEREAS, Second Party is the owner of a parcel of real property which adjoins Parcel 2; and

WHEREAS, First Party has constructed a building which encroaches approximately 2.4 feet across the northeast boundary of its property, onto the property of Second party;

## **AGREEMENT**

For and in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

- Second Party grants to First Party a permissive right to encroach upon its property, to the extent of the actual enroachment.
- First Party agrees to pay for said permissive right the sum of ONE AND NO/100THS DOLLARS (\$1.00) per year, the receipt of the first installment of which is hereby acknowledged by Second Party.

3. In the event of the destruction or removal of the encroaching building, no new construction which encroaches on the real property of Second Party shall be carried out.

4. First Party agrees that upon Second Party's demand for removal of the encroachment, First Party will remove it within sixty (60) days of receipt of written notice of said demand.

5. The provisions hereof shall operate as a covenant running with both parcels of land above described, and shall bind both parties hereto and their respective heirs, executors, administrators, and assigns.

6. This instrument and all the covenants herein contained shall remain in force and effect only so long as the present building of First Party shall remain standing; and that on the removal or destruction thereof all rights of First Party hereunder shall cease.
