## BARGAIN AND SALE DEED

KNOW ALL BY THESE PRESENTS that Paul Coker

Lot 7, Block 8, Town of Merrill, Klamath County, Oregon, according to the duly recorded Supplemental Plat filed for record August 8, 1907, in the County Clerk's office of Klamath County, Oregon.

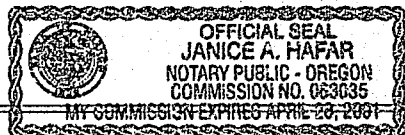
