1. NATURE OF THE ASSERTED VIOLATION:

Respondent is alleged to be "camping" on his property, in violation of Article 42 of the Klamath County Land Development Code.

2. NAMES OF THOSE WHO PARTICIPATED.

The matter was heard by the Hearings Officer August 1, 1997. The Hearings Officer in review of the violation was Neal G. Buchanan. The Respondent appeared and offered testimony. Interested persons who offered testimony were Paul Paulsen, Ed Young and Dale McKenzie. The Planning Department was represented by Kim Lundahl, and the recording secretary was Karen Burg.

LOCATION:

The property under consideration is generally located on Elk Lane in the Bly Mountain area east of Klamath Falls, Klamath County, Oregon.

4. FINDINGS OF FACT:

The Respondent appeared and testified that he had not applied for a Temporary Use Permit, but that he had reached an accommodation with the Planning Department, which might be included within the provisions of an Order of the Hearings Officer.

5. ORDER:

IT IS ORDERED that "camping" by the Respondent on Respondent's property be abandoned or alternatively brought into compliance with Article 42 (Temporary Use Permit), pursuant to the schedule as follows:

- 1. Respondent shall be required to apply for a Temporary Use Permit on or before September 1, 1997;
- 2. Respondent shall have obtained an evaluation of his proposed septic system on or before October 1, 1997; and
- 3. Respondent shall have completed installation of his approved septic system on or before December 1, 1997; PROVIDED, FURTHER that should the Respondent fail to comply with the

provisions of the foregoing agreement and Order, Respondent shall be cited to appear in Wood River Justice Court with fine suggested at \$1,000.00.
