

BEFORE THE KLAMATH COUNTY BOARD OF COMMISSIONERS

In the Matter of the Removal of the Dedication of a Portion of Klamath Memorial Park)

ORDER & DECREE 98-024

THIS MATTER having come before the Board pursuant to ORS 97.440 and at the request of the City of Klamath Falls, owner of Klamath Memorial Park, to remove the cemetery dedication on all that portion of Klamath Memorial Park lying to the east of Memorial Drive; the Board having conducted a public hearing on August 6, 1997; and on the basis thereof being sufficiently appraised in the premise does hereby find as follows:

- 1. That portion of Klamath Memorial Park lying to the east of Memorial Drive has not been and is not being used for the interment of human remains; and
2. That notice of the hearing was duly published in the Herald & News and posted on the portion of property from which the dedication is to be removed as required by ORS 97.440(2).

NOW THEREFORE, THE BOARD DOES HEREBY ORDER AND DECREE AS FOLLOWS:

The dedication set forth in Volume 8, sheet 5 (recorded 12-24-43) and in Volume 8, sheet 8 (recorded 12-13-46) in Town Plats records of the County Clerk as applies to all that portion of Klamath Memorial Park lying east of the present Memorial Drive (formerly Cumberland) is hereby removed.

This order and decree shall be recorded with the County Clerk.
