KNOW ALL MEN BY THESE PRESENTS, That John M. Schoonover

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

Lot #9: S $\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 19, TWP25S, R8E, W.M. Five acres M or L.

Subject to a thirty foot (30 ft.) wide easement along East boundary, and a fifteen foot (15 ft.) wide easement along South boundary for mutual roadway use. Subject to a power utility easement. Subject to reservations and restrictions of record.
